I. Resumen

La técnica de reposicionamiento de labios (LRT) se considera un tratamiento seguro y predecible de sonrisa gingival (GS). Sin embargo, desde que Rubinstein y Kostianovsky lo introdujeron en 1973, ha sufrido varias modificaciones. Este artículo tiene como objetivo revisar y proporcionar una recopilación histórica de la evolución de la técnica de reposicionamiento de labios (LRT) para ayudar a los médicos a comprender la descripción de cada técnica y la justificación de sus modificaciones para tratar el GS.

Se realizó una búsqueda electrónica en Medline, Scopus y Cochrane Library hasta diciembre de 2020, que incluyó los términos "reposición de labios", "técnica de reposicionamiento de labios" o "cirugía de reposicionamiento de labios" y estudios que evalúan o discuten en detalle la modificación del LRT original. La búsqueda no tiene restricciones de idioma ni de tiempo. Además, se realizó una búsqueda manual de las referencias de todos los artículos incluidos.

Las modificaciones descritas en la literatura incluyen rotura muscular, disección subperióstica de la encía, frenectomías y el uso de productos adyuvantes. Su objetivo es minimizar las recaídas, la morbilidad y mejorar la estabilidad. El malestar, la formación de cicatrices y el dolor fueron las complicaciones más frecuentes reportadas. La elección de utilizar una modificación debe analizarse y personalizarse de acuerdo con las necesidades individuales del paciente.

The Lip Repositioning Surgery: A Review of the Technique's Evolution

Abstract

The lip repositioning technique (LRT) is considered a safe and predictable gummy smile (GS) treatment. Introduction

According to some authors, the "ideal smile" involves 1 to 3 mm of exposed gingiva.^[1-3]

Thus, the excessive gingival display (EGD), also called gummy smile (GS), is an aesthetic problem that may affect a person's appearance.^[4-7] This condition is more frequent in women and during smiling^[8, 9] and has a prevalence between 11.8%^[10] and 10.57%.^[11]

Typically, a patient is diagnosed with GS or EGD when having a high smile line, showing more than 2 mm of free gingiva.^[12] A thorough examination and correct diagnosis are essential to achieve aesthetic and predictable treatment results.^[13] It is necessary to emphasize that before any surgical treatment, the gummy smile's etiology must be identified. The GS's etiology is often multifactorial, including altered passive eruption (APE), vertical maxillary excess (VME), anterior dentoalveolar extrusion, gingival enlargement, hypermobile upper lip (HUL), short lip, and asymmetrical upper lip.^[2, 9, 14, 15] When a patient presents gross overbite, VME or overgrowth of the upper jaw, orthognathic surgery is the first recommended option.^[4] However, most patients refuse this surgery due to its high morbidity and the need to be hospitalized.^[16, 17]

The lip repositioning technique (LRT) described for the first time in plastic surgery by Rubinstein and Kostianovsky^[18], is a widely used, effective, safe, and predictable treatment with an average GS reduction of 2.71 mm.^[19, 20] The LRT alone could be used when the patient presents short upper lip, HUL (lip mobility >8 mm), and VME except for severe cases^[14, 19, 21]. However, the literature describes several modifications of the original LRT using myotomies, subperiosteal dissection of the gingiva, and adjunctive product use.^[22-24]

Therefore, this article aims to review and provide a historical compilation of the lip repositioning technique (LRT) evolution to help clinicians understand each technique's description and the rationale for its modifications to treat GS.

Material and methods

Search strategy

An electronic search in Medline (via Pubmed), Scopus, and Cochrane Library (CENTRAL) was performed up to December 2020 to conduct a comprehensive review of the literature and answer the following questions:

1. What are the different modifications of the original LRT?
2. Which are the basis of the different modifications of the LRT?
3. Which are the main complications of the LRT modifications?

The search strategy included the terms "lip repositioning," "lip repositioning technique," or "lip repositioning surgery" to identify the relevant studies. The search has no language or time restrictions. Additionally, a hand-searching of the references of all included articles was performed.

Inclusion/exclusion criteria

Randomized or non-randomized clinical trials, case series, and case reports were considered for inclusion if they described a modification of the original LRT^[18]. Articles that did not provide suitable detail or description of the technique used were excluded.

The Original lip repositioning technique

Rubinstein and Kostianovsky first presented the LRT in 1972 and published it in the plastic surgery field one year later.^[18, 25] The surgery was based on a strip of maxillary labial mucosa excision to eliminate the lip "over-excursion" while smiling. The gingival display is measured from the gingival margin to the lower border of the upper lip during smiling (Figure 1). This technique performed a turndown flap to close the wound with the lower edge. The distal references of the horizontal incision coincide with the labial commissures' projection during the smile, at the second maxillary molars level. The upper edge of the horizontal incision was placed at the bottom of the upper buccal sulcus, and the lower edge 2 -3 mm above the dentoalveolar line sectioning the frenum. The removal of mucosa was partial, leaving the periosteum intact (Figure 2). Finally, the lip was immobilized using plaster or adhesive tape.

Study Selection and Data extraction

Two independent researchers (KG and A.M.) independently performed the search strategy. Titles and abstracts were independently assessed to identify relevant clinical studies. Full-text articles screening was performed to identify articles that met the inclusion criteria. Then, the same reviewers extracted data from the selected articles into tables. Any disagreement was resolved by consensus with a third examiner (A.V.)

Included articles were thoroughly assessed for content related to the LRT surgical modification technique. The extracted data included: Author (year), modifications on the lower and upper horizontal incision, distal extension references, flap/incision type, information about frenulum section, muscular modifications, use of Adjuvants. Also, data were summarized on all postoperative complications.

Results

A total of 633 citations were screened from three databases; 335 from Scopus, 241 from Medline via Pubmed, and 57 from Cochrane. Figure 3 shows the flowchart diagram. After the removal of duplicated articles, 420 articles remained for title and abstract screening. And after full-text assessment, only 23 studies remained for data extraction. The main modifications related to muscle severance or detachment, frenectomies, the horizontal incision extension, and complications reported are shown in Table 1

The lower horizontal incision along the mucogingival junction was the technique of choice. However, concerning the upper horizontal incision, authors report performing it on the sulcus^[5], the labial mucosa^[4, 26]. In contrast, others perform an apical projection to the inferior incision at 5mm^[27], 6 to 8mm^[28], 8mm^[29], 8 to 10mm^[29, 30], between 10 and 12 mm^[23, 24] or twice the amount of the EGD^[31-35]. The most frequent reference for the distal projection of the horizontal incision was the maxillary first molar.^[21, 23, 30, 32, 35, 36]. 6 authors performed a full-thickness incision^[4, 5, 21, 26, 29, 37] and 13 reported sectioning the labial frenulum.

Concerning muscle severance (Figure 4), the authors recommended muscle detached in cases of short lips^[4], muscle amputation^[5, 21, 24, 33, 37], and muscle containment with sutures^[30]. On the other hand, some authors recommend combining LRT with other therapeutic options to ensure more predictable and stable results. The most common adjuvant used were botulinum toxin (BT),^[28, 35] and spacers^[38, 39]. LRT with gingivectomy and osteotomy^[26, 40-43] was the most frequent associated surgery. Table 2 shows the summary of the adjuvants used in combination with the LRT.

Across all studies, the most frequent postoperative complication was discomfort, scar formation^[21, 23, 28, 29, 31, 32, 36], and pain^[18, 21, 29, 36]. Other LRT modifications reported

swelling,^[28, 33] ecchymosis,^[36] edema of the upper lip and perioral area,^[21, 29] minor bleeding^[21, 29], and mucocele formation.^[36]

Discussion

Among the procedures used to improve GS, the LRT reduces the elevator smile muscle's retraction by shortening the vestibule, reducing the EGD when smiling^[44]. It was first presented in 1972, published in the plastic surgery field by Rubinstein and Kostianovsky^[18, 25], and introduced years later in the dental cosmetic area by Rosenblat and Simon^[36].

This procedure has been suggested for patients requesting a less invasive procedure compared with orthognathic surgery^[16, 17] and has evolved significantly over the years.

Litton and Fournier^[4] were the first to review it in 1979, recommending a horizontal incision using the first bicuspid medial side as a reference and a full-thickness flap. Also, suggested muscle detached in cases of short lips. Miskinyar^[5] performed the original technique, finding relapses in his patients, and modified it by performing an amputation of the levator labii superioris muscle (LLSM). After reporting that muscle severance improved EGD reduction, different authors started to perform the technique using a full-thickness flap and the levator muscle myotomy.^[21, 24, 33] They indicated that this method alters the smile muscles' position, avoiding muscle pull.

Ishida et al.^[37] proposed a technique to reduce the elevator of the upper lip muscle function and a frenectomy to lengthen the upper lip. However, it required a subperiosteal dissection through the columella and lateral incisions inside the nostrils. Abdullah et al.^[29] performed a full-thickness incision 4 to 5 mm above the gingival margins from the second premolar level to the contralateral and a parallel line using a surgical caliper at approximately 8 to 10 mm apical to the first incision. After removing the soft tissue strip, the LLSM and depressor septi muscles were released and repositioned in a lower position

using circumferential sutures around the canines. Authors who support this modification using myotomy of the LLM reported fewer recurrences and greater postoperative stability than the conventional technique^[24]. Although myotomy showed a trend of greater reduction in EGD at 6-month follow-up, there are no longer-term data^[20].

the most frequent postoperative complication was discomfort, scar formation^[21, 23, 28, 29, 31, 32, 36], and pain^[18, 21, 29, 36]. Other LRT modifications reported swelling,^[28, 33] ecchymosis,^[36] edema of the upper lip and perioral area,^[21, 29] minor bleeding^[21, 29], and mucocele formation.^[36]

Rosenblat and Simon^[36] performed the horizontal incision over the mucogingival line from the first molar sectioning the frenulum. They also recommended that the amount of tissue removed should be twice the amount of gingival tissue exposed with a maximum of 10-12 mm. Jacob and Jacob^[31] evaluated the LRT with a reversible trial before mucosal cutting using sutures. Then, the incisions and the frenectomy were performed using a high-power diode laser (975 nm, 4 W, CW).

On the other hand, some modifications included leaving the maxillary labial frenulum intact. Ribeiro – Junior et al.^[23] modified the surgical procedure described by Rosenblat and Simon^[36] involving two mucosal strip removal, leaving exposed the connective tissue from the midline to the first upper molar and maintaining the frenulum intact. In the same way, Torabi et al.^[32] avoided cutting the frenulum and performed periosteal fenestrations. They used extraoral tapes to stabilize tissues as the original LRT.^[25] Similarly, Bhola et al.^[14] published a new GS classification and introduced the lip stabilization technique (LipStaT), avoiding sectioning the frenulum.

Recent modifications aimed to change the mucogingival junction position to a more coronal one without removing a mucosal strip^[27]. Alternatively, some authors perform a

customized calculation based on the amount of gingiva shown for each tooth area^[34] and smile and papillary exposure.^[26]

Combining the LRT with other approaches such as periodontal plastic surgeries, restorative procedures, or BT injections has been suggested to obtain more predictable and stable results^[20]. A review of the use of adjuvants is shown in Table 3. Ellenbogen and Swara^[38] tried to improve the LRT by partial transection of the LLSM by inserting silicone spacers and Supramid implants into a pocket created by an incision inside the nostrils. Spacers were intended to fill the muscle space to prevent future reinsertion at the same level. However, the authors reported rejection of Supramid implants. Similarly, it has been suggested to use polymethylmethacrylate (PMMA)-based bone cement fixed to the bone with fixation screws in maxillary overgrowth and subnasal skeletal depression, producing a retraction of the upper during smiling.^[39]

On the other hand, some authors recommend using the LRT with other therapeutic options in cases of APE, gingival enlargement, and preventing relapse^[20, 27, 45]. One approach is with gingivectomy,^[23] in association with gingivectomy and osteotomy^[26, 40-42] and even with digital workflows^[46].

BT type A has been recommended in cases of excessive muscle function and HUL to prevent muscle contraction.^[47] Aly et al. suggested using it as an adjuvant two weeks after the lip repositioning surgery^[28] and other authors the day after.^[35] BT injections produce lip immobilization during the healing phase, providing long-term stability of the LRT.^[28, 35]

Conclusion

Many LRT modifications have been described in the literature and aim to improve the original technique somehow. To optimize technique selection, an individualized approach is necessary. Several authors support the use of muscle severance to prevent the smile muscle from returning to its original position. In contrast, others use adjuvant products to prevent muscle movement during the healing process and minimize potential morbidity. The frenulum section's choice and the extension of the horizontal incision should be customized to the individual patient's needs. The combination with other approaches may ensure more predictable and stable results. Finally, clinicians should know the techniques, advantages, and possible complications to ensure better outcomes.

Figure 1. Illustration of the preoperative gummy smile evaluation.

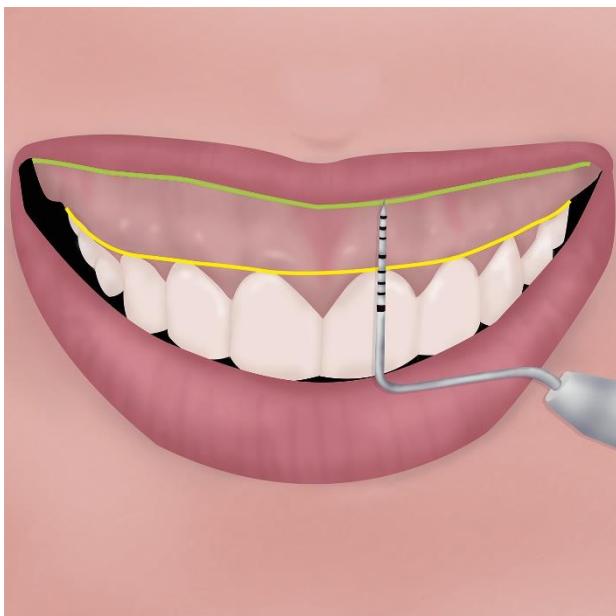


Figure 2. Illustration showing the surgical removal of the mucosal strips.

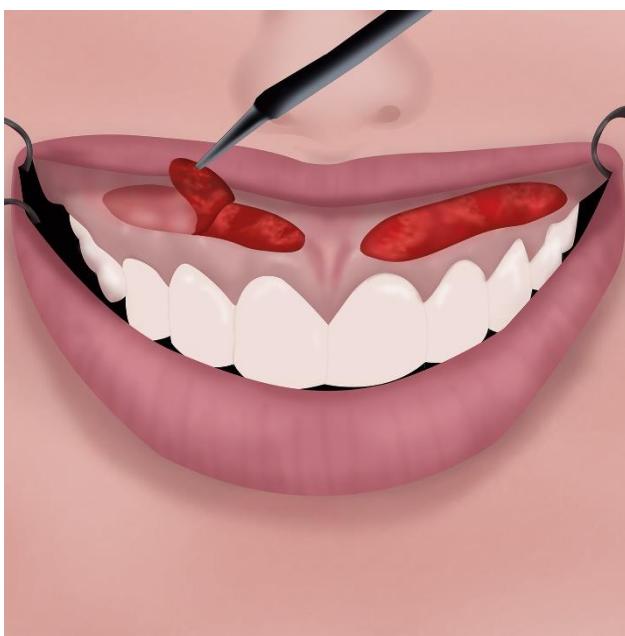


Figure 3 Flowchart diagram of the study selection

Fig 3. Prisma Flow chart

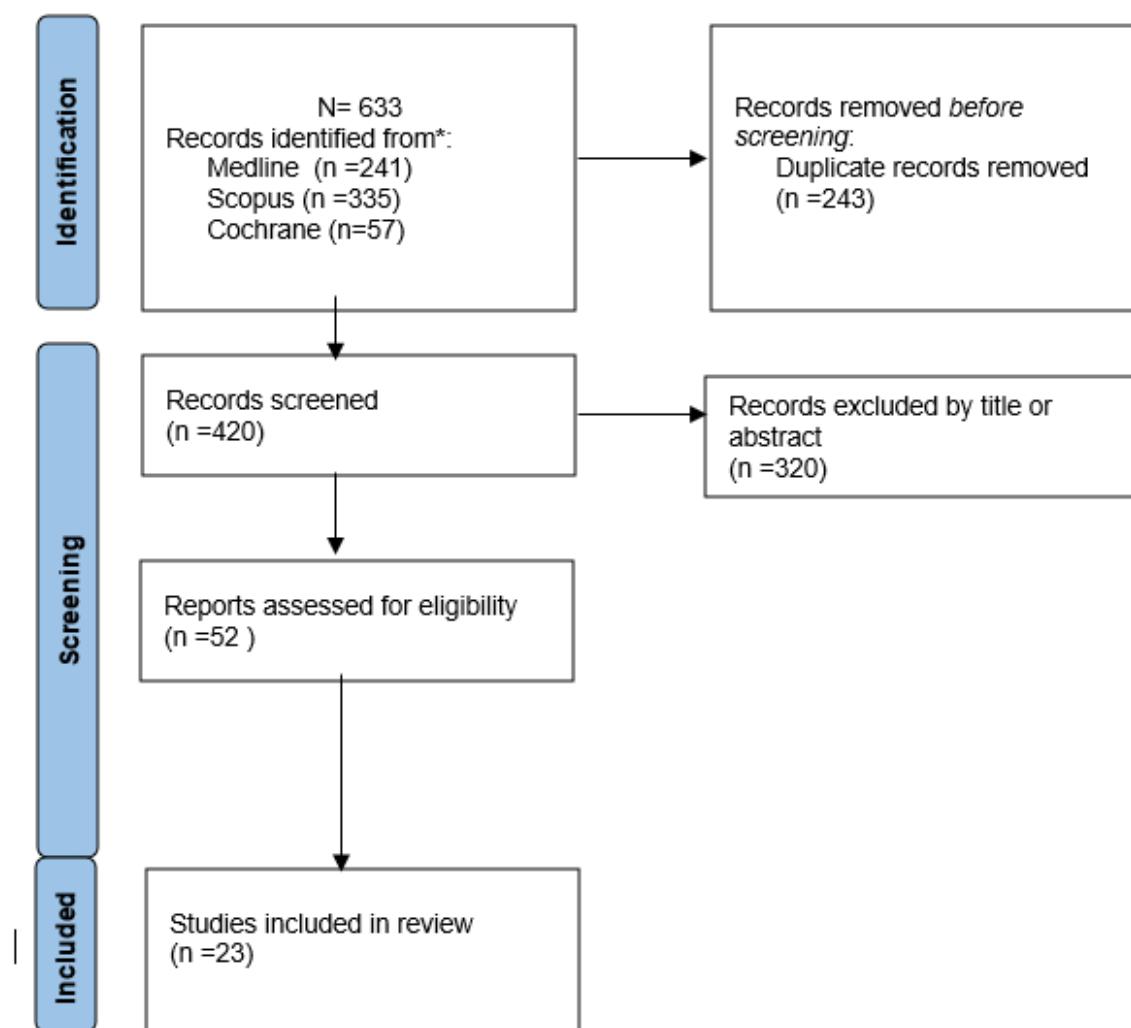


Figure 4. Illustration of the smile muscles showing amputation of both levator labii superioris muscles. Adapted from Ishida et al.^[37]

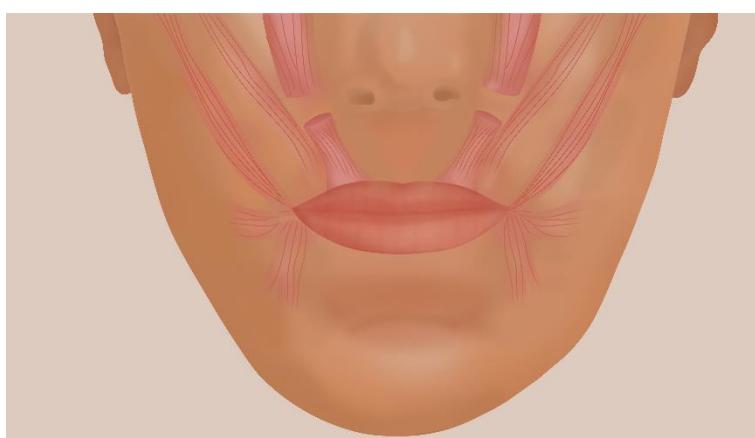

The Lip Repositioning Surgery: A Review of the Technique's Evolution

Abstract

The lip repositioning technique (LRT) is considered a safe and predictable gummy smile (GS) treatment. However, since Rubinstein and Kostianovsky introduced it in 1973, it has undergone several modifications. This article aims to review and provide a historical compilation of the lip repositioning technique (LRT) evolution to help clinicians understand each technique's description and the rationale for its modifications to treat GS.

An electronic search was performed in Medline, Scopus, and Cochrane Library up to December 2020, including the "lip repositioning" term and studies evaluating or discussing the original LRT's modification in detail. Many LRT modifications have been described in the literature to minimize relapse, morbidity and improve stability involving muscle severance, subperiosteal dissection of the gingiva, frenectomies, and adjunctive product use. Discomfort, scar formation, and pain were the most frequent complications reported. The choice to use a modification should be analyzed and customized to the individual patient's needs.

Introduction

According to some authors, the "ideal smile" involves 1 to 3 mm of exposed gingiva.^[1-3] Thus, the excessive gingival display (EGD), also called gummy smile (GS), is an aesthetic problem that may affect a person's appearance.^[4-6] This condition is more frequent in women and during smiling^[7, 8] and has a prevalence between 11.8%^[9] and 10.57%.^[10]

The lip repositioning technique (LRT) described for the first time in plastic surgery by Rubinstein and Kostianovsky^[11], is a widely used, effective, safe, and predictable treatment with an average GS reduction of 2.71 mm.^[12, 13] However, the literature describes several modifications of the original technique using myotomies, subperiosteal dissection of the gingiva, and adjunctive product use.^[14-16]

Therefore, this article aims to review and provide a historical compilation of the lip repositioning technique (LRT) evolution to help clinicians understand each technique's description and the rationale for its modifications to treat GS.

Material and methods

Search strategy

An electronic search in Medline, Scopus, and Cochrane Library databases was performed up to December 2020 to conduct an exploratory narrative review and answer the following questions:

1. What are the different modifications of the original LRT?
2. Which are the basis of the different modifications of the LRT?

The search strategy included the "lip repositioning " term to identify the relevant studies. The search has no language or time restrictions. Additionally, a hand searching of the selected articles was performed.

Study Selection

Two independent researchers (K.G. and A.M.) performed the search strategy. Titles and abstracts were assessed to identify relevant clinical studies (clinical trials, prospective case series, and case reports). Then, the same calibrated reviewers extracted data from the selected articles into tables. Any disagreement was resolved by consensus with a third examiner (A.V.)

Diagnose and Case selection

Typically, a patient is diagnosed with GS or EGD when having a high smile line, showing more than 2 mm of free gingiva.^[17] A thorough examination and correct diagnosis are essential to achieve aesthetic and predictable treatment results.^[18] It is necessary to emphasize that before any surgical treatment, the gummy smile's etiology must be identified. The GS's etiology is often multifactorial, including altered passive eruption (APE), VME, anterior dentoalveolar extrusion, gingival enlargement, hypermobile upper lip (HUL), short lip, and asymmetrical upper lip.^[2, 8, 19, 20] When a patient presents gross overbite, vertical maxillary excess (VME), or overgrowth of the upper jaw, orthognathic surgery is the first recommended option.^[4] However, most patients refuse this surgery due to its high morbidity and the need to be hospitalized.^[21, 22] The LRT alone could be used when the patient presents short upper lip, HUL (lip mobility >8 mm), and VME except for severe cases^[12, 19, 23]. Additionally, it may be used in combination with other techniques to treat APE and gingival enlargement^[24, 25].

The lip repositioning technique

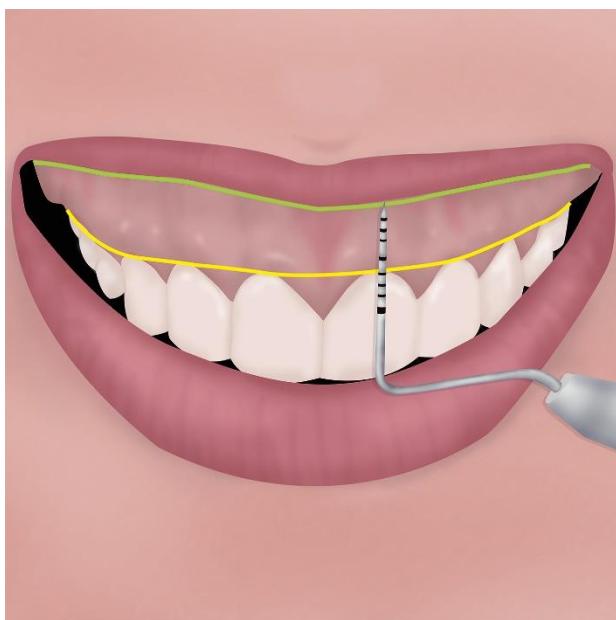


Figure 2. Illustration showing the surgical removal of the mucosal strips.

Rubinstein and Kostianovsky first presented the LRT in 1972 and published it in the plastic surgery field one year later.^[11, 26] The surgery was based on a strip of maxillary labial mucosa excision to eliminate the lip "over-excursion" while smiling. The gingival display is measured from the gingival margin to the lower border of the upper lip during smiling (Figure 1). This technique performed a turndown flap to close the wound with the lower edge. The distal references of the horizontal incision coincide with the labial commissures' projection during the smile, at the second maxillary molars level. The upper edge of the horizontal incision was placed at the bottom of the upper buccal sulcus, and the lower edge 2 -3 mm above the dentoalveolar line sectioning the frenum. The removal of mucosa was partial, leaving the periosteum intact. (Figure 2). Finally, the lip was immobilized using plaster or adhesive tape. Years later, it was introduced in the dental cosmetic area by Rosenblat and Simon^[27].

Modifications to the original technique

Surgical modifications

The LRT aims to minimize the EGD by reducing the elevator smile muscle's retraction^[28]. The main modifications related to muscle severance or detachment, frenectomies, and the horizontal incision extension are shown in Table 1.

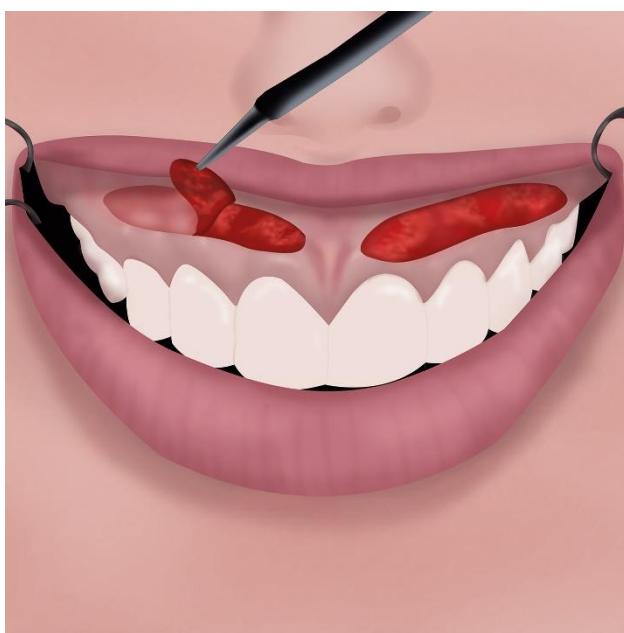


Figure 3. Illustration of the smile muscles showing amputation of both levator labii superioris muscles. Adapted from Ishida et al.^[29]

Litton and Fournier^[4] reviewed the LRT in 1979. They recommended performing the horizontal incision using the first bicuspid medial side as a reference and a full-thickness flap. Also, suggested muscle detached in cases of short lips. Miskinyar^[5] performed the original surgery, finding relapses in his patients, and modified the technique by performing an amputation of the levator labii superioris muscle (LLSM). Rosenblat and Simon^[27] performed the horizontal incision over the mucogingival line from the first molar and sectioning the frenulum. They also

recommended that the amount of tissue removed should be twice the amount of gingival tissue exposed with a maximum of 10-12 mm. On the other hand, a technique to reduce the elevator of the upper lip muscle function was proposed by Ishida et al.^[29] This procedure required a subperiosteal dissection through a 5-mm columella incision and two 5-mm lateral incisions inside the nostrils. The LLSM was identified and dissected through the lateral incisions. (Figure 3) Besides, the authors performed a frenectomy to lengthen the upper lip.

Jacob and Jacob^[30] evaluated the LRT with a reversible trial before mucosal cutting using sutures. Then, the incisions and the frenectomy were performed using a high-power diode laser (975 nm, 4 W, CW). In the same year, Ribeiro – Junior et al.^[15] modified the surgical procedure described by Rosenblat and Simon^[27] involving two mucosal strip removal, leaving exposed the connective tissue from the midline to the first upper molar and maintaining the frenulum intact. The minor salivary glands were removed when necessary. In the same way, Torabi et al.^[31] avoided cutting the frenulum and performed periosteal fenestrations. They used extraoral tapes to stabilize tissues as the original LRT.^[26]

Abdullah et al.^[32] performed a full-thickness incision 4 to 5 mm above the gingival margins from the second premolar level to the contralateral. A parallel line was made using a surgical caliper at approximately 8 to 10 mm apical to the first incision. After removing the soft tissue strip, the LLSM and depressor septi muscles were released and repositioned in a lower position using circumferential sutures around the canines. In 2015, Bhola et al.^[19] published a new GS classification and introduced the lip stabilization technique (LipStaT).

Littuma et al.^[33] described an innovative suture procedure designed to maintain the traction and containment of the smile elevator muscles. After reporting that muscle severance improved EGD reduction, different authors started to perform the technique using a full-thickness flap and the levator muscle myotomy.^[16, 23, 34] They indicated that this method alters the smile muscles' position, avoiding muscle pull.

Recently, Zardawi et al. [24] modified the technique by changing the mucogingival junction position to a more coronal without removing a mucosal strip. On the other hand, Duruel et al. [35] presented a tooth-based LRT calculating the amount of mucosa to be removed based on the amount of gum shown for each tooth area. Similarly, Chacon^[36] performed a calculation of the average tissue to be removed and suggested a microsurgical division of mucosa, periosteum, and bone with periosteum fixation.

It is essential to point out that some authors use a laser to remove the mucosa strip from the maxillary buccal vestibule.^[30, 37-39]

Improvements with the use of adjuvants and spacers

A recent systematic review^[13] suggested combining the LRT with other approaches such as periodontal plastic surgeries, restorative procedures, or BT injections to obtain more predictable and stable results. A review of the use of adjuvants is shown in Table 2.

Ellenbogen and Swara^[40] tried to improve the LRT by partial transection of the LLSM by inserting silicone spacers and Supramid implants into a pocket created by an incision inside the nostrils. The use of spacers was intended to fill the muscle space to prevent future reinsertion at the same level. However, the authors reported rejection of Supramid implants. Similarly, it has been suggested to use polymethylmethacrylate (PMMA)-based bone cement fixed to the bone with fixation screws in maxillary overgrowth and subnasal skeletal depression producing a retraction of the upper during smiling.^[41]

Combination with other surgical techniques

On the other hand, some authors recommend combining the LRT with other therapeutic options for GS to ensure more predictable and stable results. One approach is the combination with a gingivectomy.^[15] However, some authors^[36, 42-44] recommend using the LRT in association with gingivectomy and osteotomy. In cases of excessive muscle function and HUL, botulinum toxin

type A (BT) has been recommended to prevent muscle contraction^[45]. Aly et al. suggested its use as an adjuvant two weeks after the lip repositioning surgery^[46] and other authors the day after.^[47] BT injections produce lip immobilization during the healing phase, providing long-term stability of the LRT.^[46, 47]

Complications

Postoperative complications have been described in the literature, being discomfort, scar formation^[15, 23, 27, 30-32, 46], and pain^[11, 23, 27, 32] the most frequently reported.

Other LRT modifications reported swelling,^[34, 46] ecchymosis,^[27] edema of the upper lip and perioral area,^[23, 32] minor bleeding^[23, 32], and mucocele formation.^[27] A review of the complications reported is also shown in Table 1.

Conclusion

Many LRT modifications have been described in the literature and aim to improve the original technique somehow. Several authors support the use of muscle severance to prevent the smile muscle from returning to its original position, while others use adjuvant products to prevent muscle movement during the healing process and minimize potential morbidity. The frenulum section's choice and the extension of the horizontal incision should be customized to the individual patient's needs. The combination with other approaches may ensure more predictable and stable results. Finally, clinicians should know the techniques, advantages, and possible complications to ensure better outcomes.

Figure 1. Illustration of the preoperative gummy smile evaluation.

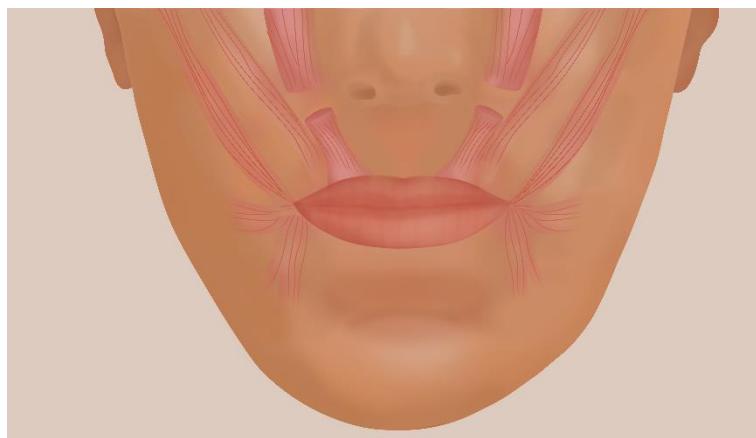

Rubinstein y Kostianovsky presentaron por primera vez el LRT en 1972 y lo publicaron en el campo de la cirugía plástica un año después. [18, 25] La cirugía se basó en una tira de escisión de la mucosa labial maxilar para eliminar la "sobreexcursión" del labio mientras sonreía. La visualización gingival se mide desde el margen gingival hasta el borde inferior del labio superior durante la sonrisa (Figura 1). Esta técnica realizó un colgajo de cobertura para cerrar la herida con el borde inferior. Las referencias distales de la incisión horizontal coinciden con la proyección de las comisuras labiales durante la sonrisa, a nivel de los segundos molares superiores. El borde superior de la incisión horizontal se colocó en la parte inferior del surco bucal superior y el borde inferior 2-3 mm por encima de la línea dentoalveolar que secciona el frenillo. La remoción de mucosa fue parcial, dejando intacto el periostio (Figura 2). Finalmente, se inmovilizó el labio con yeso o cinta adhesiva.

Selección de estudios y extracción de datos

Dos investigadores independientes (KG y A.M.) realizaron de forma independiente la estrategia de búsqueda. Los títulos y resúmenes se evaluaron de forma independiente para identificar estudios clínicos relevantes. Se realizó una selección de artículos de texto completo para identificar los artículos que cumplían con los criterios de inclusión. Luego,

los mismos revisores extrajeron los datos de los artículos seleccionados en tablas.

Cualquier desacuerdo se resolvió por consenso con un tercer examinador (A.V.)

Los artículos incluidos fueron evaluados minuciosamente por el contenido relacionado con la técnica de modificación quirúrgica LRT. Los datos extraídos incluyeron: Autor (año), modificaciones en la incisión horizontal inferior y superior, referencias de extensión distal, tipo de colgajo / incisión, información sobre la sección del frenillo, modificaciones musculares, uso de adyuvantes. Además, se resumieron los datos sobre todas las complicaciones posoperatorias.

Resultados

Se seleccionaron un total de 633 citas de tres bases de datos; 335 de Scopus, 241 de Medline a través de Pubmed y 57 de Cochrane. La figura 3 muestra el diagrama de flujo. Después de eliminar los artículos duplicados, quedaron 420 artículos para la selección de títulos y resúmenes. Y después de la evaluación del texto completo, solo quedaron 23 estudios para la extracción de datos. Las principales modificaciones relacionadas con la ruptura o desprendimiento muscular, las frenectomías, la extensión de la incisión horizontal y las complicaciones reportadas se muestran en la tabla 1.

La incisión horizontal inferior a lo largo de la unión mucogingival fue la técnica de elección. Sin embargo, con respecto a la incisión horizontal superior, los autores informan que la realizan en el surco [5], la mucosa labial [4, 26]. Por el contrario, otros realizan una proyección apical a la incisión inferior a 5 mm [27], 6 a 8 mm [28], 8 mm [29], 8 a 10 mm [29, 30], entre 10 y 12 mm [23, 24] o dos veces la cantidad de EGD [31-35]. La referencia más frecuente para la proyección distal de la incisión horizontal fue el primer molar superior [21, 23, 30, 32, 35, 36]. Seis autores realizaron una incisión de espesor total [4, 5, 21, 26, 29, 37] y 13 informaron seccionar el frenillo labial.

Con respecto a la ruptura del músculo (Figura 4), los autores recomendaron el desprendimiento del músculo en casos de labios cortos [4], la amputación del músculo [5, 21, 24, 33, 37] y la contención del músculo con suturas [30]. Los autores recomiendan combinar LRT con otras opciones terapéuticas para asegurar resultados más predecibles y estables. Los adyuvantes más utilizados fueron la toxina botulínica (BT), [28, 35] y los espaciadores [38, 39]. La TRL con gingivectomía y osteotomía [26, 40-43] fue la cirugía asociada más frecuente. La Tabla 2 muestra el resumen de los adyuvantes usados en combinación con la LRT.

En todos los estudios, la complicación postoperatoria más frecuente fue el malestar, la formación de cicatrices [21, 23, 28, 29, 31, 32, 36] y el dolor [18, 21, 29, 36]. Otras modificaciones de LRT informaron hinchazón, [28, 33] equimosis, [36] edema del labio superior y área perioral, [21, 29] hemorragia leve [21, 29] y formación de mucocele. [36]

Discusión

Entre los procedimientos utilizados para mejorar la GS, el LRT reduce la retracción del músculo elevador de la sonrisa al acortar el vestíbulo, reduciendo la EGD al sonreír [44]. Fue presentado por primera vez en 1972, publicado en el campo de la cirugía plástica por Rubinstein y Kostianovsky [18, 25], e introducido años más tarde en el área de la cosmética dental por Rosenblat y Simon [36]. Este procedimiento ha sido sugerido para pacientes que solicitan un procedimiento menos invasivo en comparación con la cirugía ortognática [16, 17] y ha evolucionado significativamente a lo largo de los años.

Litton y Fournier [4] fueron los primeros en revisarlo en 1979, recomendando una incisión horizontal utilizando el primer lado medial premolar como referencia y un colgajo de espesor completo. Además, sugirió desprendimiento de músculo en casos de labios cortos. Miskinyar [5] realizó la técnica original, encontrando recaídas en sus

pacientes, y la modificó realizando una amputación del músculo elevador del labio superior (LLSM). Después de informar que la ruptura muscular mejoró la reducción de EGD, diferentes autores comenzaron a realizar la técnica utilizando un colgajo de espesor total y la miotomía del músculo elevador. [21, 24, 33] Indicaron que este método altera la posición de los músculos de la sonrisa, evitando el tirón muscular.

Ishida y otros [37] propuso una técnica para reducir la función del músculo elevador del labio superior y una frenectomía para alargar el labio superior. Sin embargo, requirió una disección subperióstica a través de la columela e incisiones laterales dentro de las fosas nasales. Abdullah y otros [29] realizó una incisión de espesor total de 4 a 5 mm por encima de los márgenes gingivales desde el nivel del segundo premolar hasta el contralateral y una línea paralela utilizando un calibre quirúrgico a aproximadamente 8 a 10 mm apical de la primera incisión. Después de retirar la tira de tejido blando, los músculos LLSM y depresor septi se soltaron y se reposicionaron en una posición más baja utilizando suturas circunferenciales alrededor de los caninos. Los autores que apoyan esta modificación mediante la miotomía del LLM informaron menos recurrencias y una mayor estabilidad postoperatoria que la técnica convencional [24]. Aunque la miotomía mostró una tendencia a una mayor reducción de la EGD a los 6 meses de seguimiento, no hay datos a más largo plazo [20].

La complicación postoperatoria más frecuente fue el malestar, la formación de cicatrices [21, 23, 28, 29, 31, 32, 36] y el dolor [18, 21, 29, 36]. Otras modificaciones de LRT informaron hinchazón, [28, 33] equimosis, [36] edema del labio superior y área perioral, [21, 29] hemorragia leve [21, 29] y formación de mucocele. [36]

Rosenblat y Simon [36] realizaron la incisión horizontal sobre la línea mucogingival desde el primer molar seccionando el frenillo. También recomendaron que la cantidad de tejido extraído sea el doble de la cantidad de tejido gingival expuesto con un máximo de

10-12 mm. Jacob y Jacob [31] evaluaron el LRT con una prueba reversible antes del corte de la mucosa con suturas. A continuación, se realizaron las incisiones y la frenectomía con un láser de diodo de alta potencia (975 nm, 4 W, CW).

Por otro lado, algunas modificaciones incluyeron dejar intacto el frenillo labial maxilar. Ribeiro - Junior y otros [23] modificó el procedimiento quirúrgico descrito por Rosenblat y Simon [36] que implica la extracción de dos tiras mucosas, dejando expuesto el tejido conectivo desde la línea media hasta el primer molar superior y manteniendo intacto el frenillo. De la misma forma, Torabi et al. [32] evitó cortar el frenillo y realizó fenestraciones periósticas. Utilizaron cintas extraorales para estabilizar los tejidos como el LRT original. [25] Del mismo modo, Bhola et al. [14] publicó una nueva clasificación GS e introdujo la técnica de estabilización de labios (LipStaT), evitando seccionar el frenillo.

Las modificaciones recientes tenían como objetivo cambiar la posición de la unión mucogingival a una más coronal sin quitar una tira mucosa [27]. Alternativamente, algunos autores realizan un cálculo personalizado basado en la cantidad de encía mostrada para cada área del diente [34] y sonrisa y exposición papilar. [26]

Se ha sugerido combinar la LRT con otros enfoques como las cirugías plásticas periodontales, los procedimientos de restauración o las inyecciones de BT para obtener resultados más predecibles y estables [20]. En la Tabla 3 se muestra una revisión del uso de adyuvantes. Ellenbogen y Swara [38] intentaron mejorar el LRT mediante una sección parcial del LLSM insertando espaciadores de silicona e implantes Supramid en un bolsillo creado por una incisión dentro de las fosas nasales. Los espaciadores estaban destinados a llenar el espacio muscular para evitar una futura reinserción al mismo nivel. Sin embargo, los autores informaron sobre el rechazo de los implantes Supramid. Asimismo, se ha sugerido utilizar cemento óseo a base de polimetilmetacrilato (PMMA) fijado al

hueso con tornillos de fijación en sobrecrecimiento maxilar y depresión esquelética subnasal, produciendo una retracción del empeine durante la sonrisa. [39]

Por otro lado, algunos autores recomiendan utilizar la LRT con otras opciones terapéuticas en casos de APE, agrandamiento gingival y prevención de recaídas [20, 27, 45]. Un enfoque es la gingivectomía, [23] en asociación con la gingivectomía y la osteotomía [26, 40-42] e incluso con flujos de trabajo digitales [46].

Se ha recomendado la BT tipo A en casos de función muscular excesiva y HUL para prevenir la contracción muscular. [47] Aly y col. sugirieron usarlo como adyuvante dos semanas después de la cirugía de reposicionamiento del labio [28] y otros autores al día siguiente. [35] Las inyecciones de BT producen inmovilización de los labios durante la fase de cicatrización, lo que proporciona estabilidad a largo plazo de la LRT. [28, 35]

Conclusión

Muchas modificaciones de LRT se han descrito en la literatura y tienen como objetivo mejorar la técnica original de alguna manera. Para optimizar la selección de técnicas, es necesario un enfoque individualizado. Varios autores apoyan el uso de la separación muscular para evitar que el músculo de la sonrisa vuelva a su posición original. Por el contrario, otros usan productos adyuvantes para prevenir el movimiento muscular durante el proceso de curación y minimizar la morbilidad potencial. La elección de la sección del frenillo y la extensión de la incisión horizontal deben adaptarse a las necesidades individuales del paciente. La combinación con otros enfoques puede garantizar resultados más predecibles y estables. Finalmente, los médicos deben conocer las técnicas, ventajas y posibles complicaciones para asegurar mejores resultados.

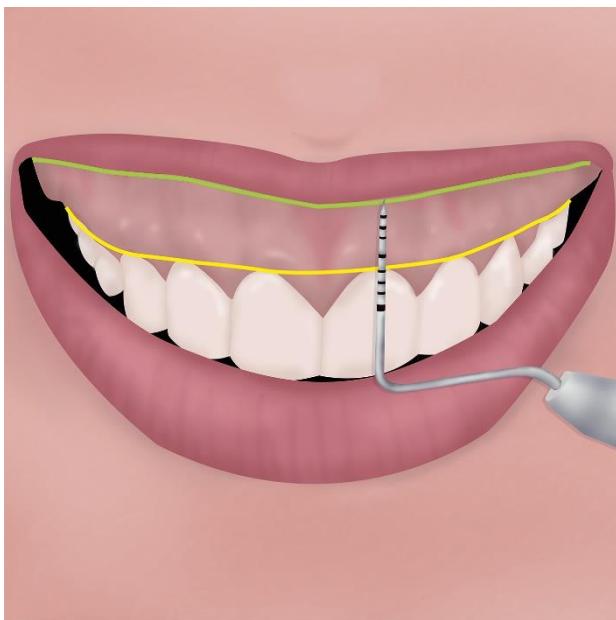


Figura 2. Ilustración que muestra la extirpación quirúrgica de las tiras mucosas.

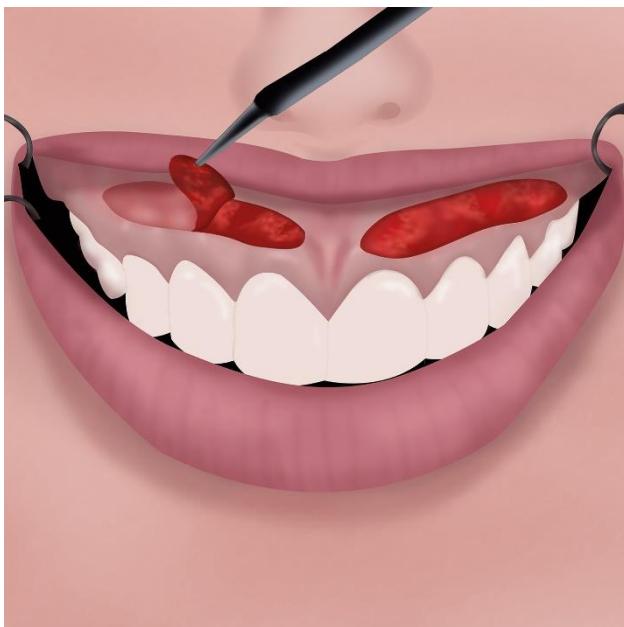


Figura 3 Diagrama de flujo de la selección del estudio

Fig 3. Prisma Flow chart

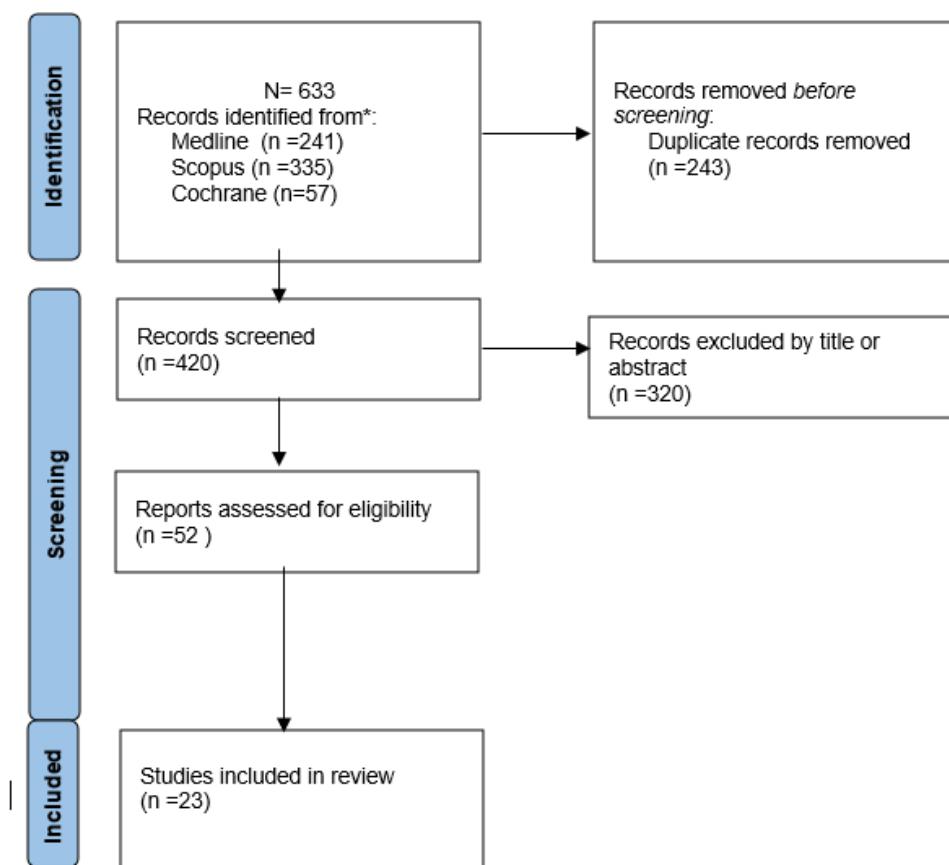
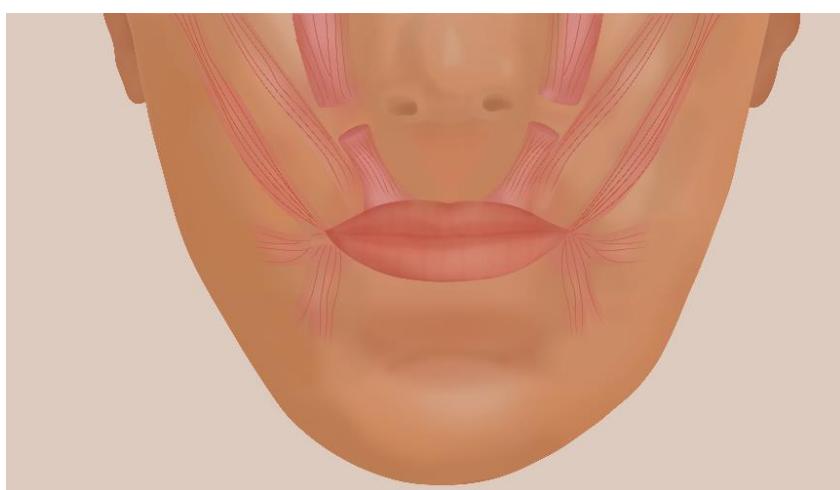

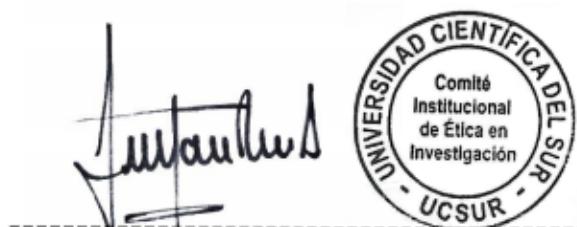
